What is the purpose of this update?

This document tells you how the Lifetime Active Growth Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Trustee Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Lifetime Active Growth Fund aims to provide annual returns of 10% after the base fund fee* but before tax and before the performance fee, over the minimum recommended investment timeframe. The Fund invests primarily in equities, with a moderate allocation to fixed interest securities.

What are the risks of investing?

Risk indicator for the Lifetime Active Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


The market index annual return for the Fund is a composite index, calculated using the return of each asset class index the Fund invests in, weighted by the Fund's benchmark asset allocation.

What fees are investors charged?

Annual membership fee calculation involves calculating the total of member fees payable across all those participating employers where the member pays for the fees and dividing by the total number of members from all participating employers and multiplying by 12 to convert to an annual average. Annual membership fees were charged during the period however they are no longer charged.		

All fees are inclusive of GST (if any).

Example of how this applies to an investor


Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges and tax were deducted of \$86.00 (that is -0.86% of his initial \$10,000). Ben also paid \$22.35 in other charges. This gives Ben a total loss after tax of \$108.35 for the year.


Actual investment mix*
